PRAYER IN W.P.NOS.23164 & 23166 OF 2017:-

Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Mandamus, directing the respondents to pay a sum of Rs.5,00,000/- (Five Lakhs only) for not displaying the name of the petitioner during the District wise counselling held for the academic year 2017-18 in terms of GO.Ms.115 Labour & Employment Department, dated 19.07.2012, and the orders passed in W.P.No.22119 of 2016 dated 18.04.2017.

PRAYER IN W.P.NO.23165 OF 2017:-

COMMON ORDER

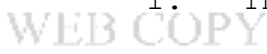
The learned counsel appearing for the petitioner seeks permission to withdraw this Writ Petition.
