However, due to political pressure, once again the third respondent police is calling these petitioners, who are neighbours of Jayanthi and harassing them.

4. The learned Government Advocate (Crl.Side) appearing for the respondents submitted that the complaint given by Saroja in Crime No.672 of 2019 has been closed on 17.06.2022.
