### **ORDER**

For the foregoing reasons, this Court directs the 1<sup>st</sup> respondent to pass final orders on merits and in accordance with law on the petitioner's representation dated 06.08.2021 seeking for revocation of the suspension order dated 12.02.2013 issued to him, within a period of twelve weeks from the date of receipt of a copy of this order.

7. With the aforesaid directions, this writ petition stands disposed of. No costs. Consequently, connected miscellaneous petitions are closed.
