2.The case of the petitioners is that the petitioners land was acquired for the purpose of Sipcot – Cheyyar Industrial Expansion Project and aggrieved by the compensation amount, they made representation to the respondents seeking to enhance the compensation amount and since the same has not yet been considered, has filed this writ petition.

3.The learned counsel appearing for the petitioner submitted that this Court may issue direction to the respondents to consider the petitioners representation dated 07.04.2014 in terms of Section 8 of the Tamil Nadu Acquisition of Land for Industrial Purposes Act and to
