ORDER

The Writ Petition has been filed to direct the respondent to give permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Nanjai Uthukuli Village Arulmigu Sree Maha Mariyamman Temple Festival at Modakurichi Taluk, Erode District on 08.12.2022 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 24.11.2022.

The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 08.12.2022 between 06.00 pm to 11.00 pm, in the temple festival at Nanjai Uthukuli Village Arulmigu Sree Maha Mariyamman Temple Festival at Modakurichi Taluk, Erode District, the petitioner has sent a representation, dated 24.11.2022 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 24.11.2022 and pass suitable orders based on the above said circular.

With the above direction, this Writ Petition is **disposed of**. No costs.
