Therefore, in order to release the said document, the petitioner has given a representation to the respondent on 13.04.2022 and the same since has not been considered so far the petitioner has moved the present writ petition with the aforesaid prayer.

3. Heard the learned counsel for the petitioner and the learned Special Government Pleader.

4. Learned Special Government Pleader has submitted that the said representation of the petitioner dated 13.04.2022 would be considered and decided by the respondent on merits and in accordance with law within a time frame that may be stipulated by this Court.

5. Having considered the said submission made by the learned Special Government Pleader and the innocuous nature of the prayer, this Court is inclined to dispose of this writ petition with the following order.
