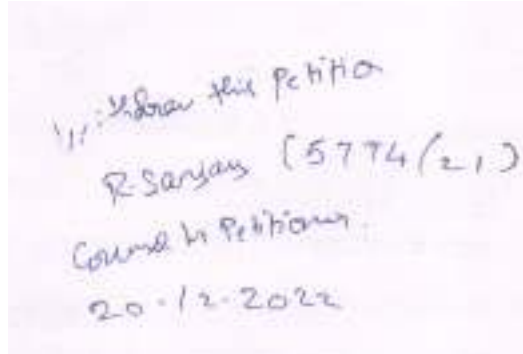
### **ORDER**
