11.00 p.m at "Nathakkadaiyur Village Arulmigu Sree Mariyamman Temple Festival" at Kangeyam Taluk, Tiruppur District, by considering the petitioner's representation dated 25.11.2022.

The learned counsel for the petitioner submitted that in order to conduct cultural programme on 21.12.2022 between 06.00 p.m to 11.00 p.m, in the event of "Nathakkadaiyur Village Arulmigu Sree Mariyamman Temple Festival" Kangeyam Taluk, Tiruppur District, the petitioner has sent a representation, dated 25.11.2022 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.
