11.00 p.m at "Bhavani, West Kannara Street Arulmigu Sree Mariyamman Temple Maha Kumbabishekam Festival" at Bhavani Taluk, Erode District, by considering the petitioner's representation dated 26.11.2022.

The learned counsel for the petitioner submitted that in order to conduct cultural programme on 07.12.2022 between 06.00 p.m to 11.00 p.m, in the event of "Bhavani West Kannara Street Arulmigu Sree Mariyamman Temple Maha Kumbabishekam Festival" Bhavani Taluk, Erode District, the petitioner has sent a representation, dated 26.11.2022 to the respondent.
