Heard Mr.Yogesh Kannadasan, learned Special Government Pleader appearing for the respondent who would submit that, if the petitioner already made application through online and paid the necessary fee to that effect, certainly the request of the petitioner would be considered for surveying the land in question and accordingly the needful would be undertaken within a time frame that may be stipulated by this Court.
