2. The Writ Petition has been filed for directing the First to Third Respondents to dispose the representation dated 24.11.2017 made by the Petitioner.

Ka. 3704/2018/ThaPuKu 1 dated 21.02.2018 passed by the Second Respondent and he has made an endorsement to that effect.
