Heard Mr. K.M.Ramesh, Learned Counsel for the Petitioner and Mr. G.Saravanakumar, Learned Counsel for the Respondents, and perused the materials placed on record, apart from the pleadings of the parties.

2. The Writ Petition has been filed for directing the Respondents to implement the order dated 10.05.2016 in A.P. No. 320 of 2013 whereby the approval for termination of the Petitioner was rejected by the Special Deputy Commissioner of



Labour, Chennai (hereinafter referred to as 'the Authority' for short). The said order, which had been challenged by the Second Respondent in W.P. No. 18738 of 2017, has been set aside by this Court and the matter has been remitted to the concerned authority in a separate order dated 17.02.2022 and its outcome would govern the rights of the respective parties. As such, the relief sought by the Petitioner does not remain for consideration.

In the result, the Writ Petition is disposed on the aforesaid terms. No costs.
