ORDER

This writ petition has been filed for a mandamus seeking for a direction to the first respondent to pass final orders on the third respondent's proposal dated 02.01.2019 seeking approval for the appointment of the petitioner as an Office Assistant within a time frame to be fixed by this Court.

2. The third respondent college is a minority institution. The third respondent has appointed the petitioner as an Office Assistant. The third respondent college has sent a proposal on 02.01.2019 to the first respondent requesting them to approve the petitioner's appointment as an Office Assistant. According to the petitioner, the Office Assistant post is a sanctioned post. Since final orders have not been passed on the third respondent's proposal referred to supra, the petitioner has filed this writ petition.
