2. Learned counsel for the petitioner submitted that the petitioner filed a private complaint under Section 156(3) Cr.P.C. The learned Judicial Magistrate, Rasipuram in Cr.M.P.No.1975 of 2021 forwarded the complaint filed under Section 156(3) Cr.P.C., to the second respondent Police with a direction to investigate the matter and file a report.
