ORDER

2. The Writ Petition has been filed seeking return of the original educational Certificates given by the petitioner, while executing a bond for doing Government Service, pursuant to the medical course which he had undergone.

3. It is stated that the two years period of service is also completed.

4. The medical certificates cannot be retained by the respondents, as they are the valuable properties of the petitioner.
