The learned counsel for the petitioner would submit that the Court below enlarged the petitioner on bail on a condition that the petitioner shall execute a bond for Rs.10,000/- with two acceptable and reliable sureties each for a like sum to the satisfaction of the learned V Metropolitan Magistrate, Egmore, Chennai. On condition that one among the sureties must be a Government surety. However, the petitioner has come before this Court for modification of the condition since he was unable to make arrangements for Government surety.

3. In view of the above submission, the condition imposed by the learned Principal Special Court for EC and NDPS Act, Chennai in Crl.M.P.No.5571 of 2022 dated 28.11.2022 is modified to the effect that the petitioner shall execute a bond for Rs.10,000/- with two acceptable and reliable sureties each for a like sum to the satisfaction of the learned V Metropolitan Magistrate, Egmore, Chennai. All other conditions remain unaltered.
