3. The learned counsel appearing for the petitioner submitted that no such termination order has been served on the petitioner.

4. This Court does not intend to go into the disputed fact that such termination order was served or not. Liberty is granted to the petitioner to challenge the order of termination dated 05.08.2017 to meet the ends of justice. As such the prayer sought for by the present writ petitioner is not considered in the present writ petition.

5. In the light of the above observations and the liberty granted to the petitioner, this Writ Petition stands closed. No order as to costs. Consequently, connected Miscellaneous Petition is closed.
