The Writ Petition has been filed seeking to direct the respondent to give permission and police protection to conduct Cultural Programme (Adal Padal Nigalchi) in the event of Thandampalayam Village Arulmigu Sree Sakthi Vinayagar & Makaliyamman Temple Festival at Kodumudi Taluk, Erode District on 28.12.2022 between 06.00.p.m., and 11.00.p.m., by considering the petitioner's representation dated 12.12.2022.

Learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Thandampalayam Village Arulmigu Sree Sakthi Vinayagar & Makaliyamman Temple Festival at Kodumudi Taluk, Erode District on 28.12.2022 between 06.00.p.m., and 11.00.p.m., the petitioner has sent a representation, dated 12.12.2022 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. Learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

4. I have considered the submission of the learned counsel appearing for the petitioner and the learned Government Advocate (Crl.Side) appearing for the respondent police.

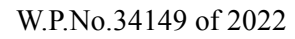

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 12.12.2022 and pass suitable orders based on the above said circular.
