Nigalchi) in the event of Arul Mighu Sri Panchainaayagi Amman Thirukoil, Kolapallur Village, Gobichettipalayam Taluk, Erode District on 30.12.2022 based on the petitioner's representation dated 16.12.2022.

The learned counsel for the petitioner submitted that in order to conduct cultural programme on 30.12.2022 between 06.00 p.m to 11.00 p.m, in the event of Arul Mighu Sri Panchainaayagi Amman Thirukoil, Kolapallur Village, Gobichettipalayam Taluk, Erode District, the petitioner has sent a representation, dated 16.12.2022 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. The learned Government Advocate (Crl.Side), appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 16.12.2022 and pass suitable orders based on the above said circular. Uploaded copy can be utilized for the purpose of execution of the order.
