ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Sanarpalayam Village Arulmigu Sree Bhagavathiyamman Temple Festival at Paramathi Velur Taluk, Namakkal District on 29.12.2022 between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 14.12.2022.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Sanarpalayam Village Arulmigu Sree Bhagavathiyamman Temple Festival at Paramathi Velur Taluk, Namakkal District on 29.12.2022 the petitioner has sent a representation, dated 14.12.2022 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Criminal side) appearing for the respondent submitted that the respondent police has received the
