ORDER

The Writ Petition has been filed to direct the respondents to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Christmas festival, Periyar Nagar, Chinnapuliyur village, Elavamalai Post, Bhavani Taluk, Erode District, on 26.12.2022 between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 10.12.2022.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Christmas festival, Periyar Nagar, Chinnapuliyur village, Elavamalai Post, Bhavani Taluk, Erode District, on 26.12.2022, the petitioner has sent a representation, dated 10.12.2022 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Criminal side) appearing for the respondents submitted that the respondent police has received the

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 10.12.2022 and pass suitable orders based on the above said circular.
