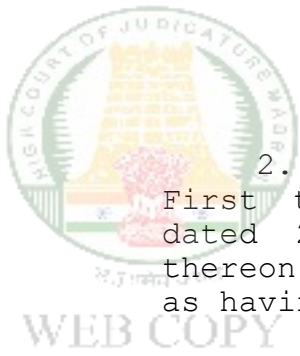
Prayer:- Writ Petition filed under Article 226 of the
