The learned counsel for the petitioner submitted that in order to conduct cultural programme on 30.12.2022 between 06.00 p.m to 11.00 p.m, in the event of Sri Mahakaliyamman & Sri Mariamman Temple Festival at Baliyakadu, Madathupalayam Village, Thingalur Post, Perundurai Taluk, Erode District, the petitioner has sent a representation, dated 21.12.2022 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 21.12.2022 and pass suitable orders based on the above said circular. Uploaded copy can be utilized for the purpose of execution of the order.
