On 18.11.2022, the petitioner had approached the second respondent, by way of an application seeking issuance of the first graduation certificate, however, the said application was rejected by the second respondent vide impugned rejection order dated 15.12.2022. 5. It is submitted by Mr.P.Gurunathan, the learned Additional Government Pleader appearing for the respondent that the said representation of the petitioner would be considered and orders will be passed thereon in accordance with law.

It is made clear that this Court has not expressed any views with regard to the merits of the representation and it is open to the third respondent to consider the representation on its own merits.

7. With the above direction, the Writ Petition stands disposed of. No costs. Consequently, the connected Miscellaneous Petition is closed.
