COMMON ORDER

These writ petitions have been filed challenging the impugned letter dated 20.07.2017 issued by the 1st respondent and quash the same and consequently directing the respondents to allocate regional wise reservation of seats MBBS Course for Karaikal, Mahe and Yanam regions and to make a fresh admission of MBBS Course for 2017-18 in the Puducherry Union Territory respectively in the light of judgment in W.P.No.13130 of 2010 dated 06.08.2010.

2. Today, when the matters taken up for hearing, the learned counsel for petitioners would submit that though the Writ Petitions filed challenging
