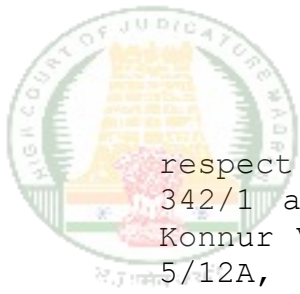

ORDER

This writ petition has been filed to issue a Writ of Mandamus, directing the respondents to consider Petitioner representation dated 15.11.2019 regarding the issue of Patta in



respect of property situate at No:71, Konnur Village, S.No.341/1, 342/1 and 343/1, TS No: 48, Block No: 54, Chennai - 600 049, Konnur Villivakkam Redhills Road, Near Samiyar Thottam, Door No: 5/12A, Chennai Corporation Limit, Ayanavaram Taluk, Chennai Central Revenue Division, Chennai Corporation Zone No: 08, Ward No: 094, Property Tax No: 09737, to the extent of 725 Sq.ft and Pathway 125 Sq.ft, total extent 850 Sq.ft Land and Building.

2. The petitioner submitted representation dated 15.11.2019 before the respondents for issuance of patta for the subject property. The 3<sup>rd</sup> respondent conducted detailed enquiry and by an order dated 05.02.2020 rejected the request made by the petitioner.
