3. The Writ Petition has been filed challenging the G.O. Ms. No. 697, Home (Transport-5) Department dated 05.08.2010 issued by the First Respondent and an Order in R. No. 22370/H1/2008, dated 17.06.2015 passed by the Second Respondent insofar as it relates to the driving school of the Petitioner in this case.

4. It has been brought to notice that after the filing of the Writ Petition, the impugned orders have been modified by G.O. Ms. No. 215, Home (Transport-5) Department dated 05.05.2022 issued by the First Respondent, in

furtherance to the order dated 15.09.2015 in W.P. No. 19362 of 2015 etc., batch passed by this Court and it has been decided to allow the Heavy Vehicles Driving School to conduct one day refresher training to the Heavy Vehicles Driver so as to issue Certificates to them for renewal of their licences and its copy has been produced. In such circumstances, nothing remains for further consideration in the Writ Petition.

5. In fine, the Writ Petition is disposed. Consequently, the connected Miscellaneous Petitions are closed. No costs.
