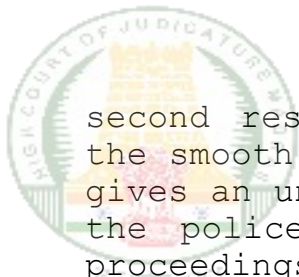

ORDER

The second respondent while issuing the proceedings permitting the holding of the event shall stipulate appropriate conditions for adhering to Covid-19 protocol. I make it clear that the order has been passed in this writ petition based on the position obtaining today. It is of-course open to the second respondent to take a call, if any substantial lockdown restriction is imposed by the Government.

3. Recording the said undertaking, this Writ Petition is allowed. No costs.
