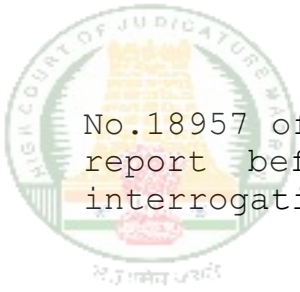
This petition has been filed to relax the condition imposed on the petitioners in Crl.O.P.(MD)No.18957 of 2021 on 08.12.2021.
