PRAYER: Contempt Petition filed under Section 11 of Contempt of Courts Act, 1971, to punish the respondent for the willful and deliberate disobedience to the orders of this Court made in W.P.(MD) No.7451 of 2021, dated 01.04.2021.

Prayer in WP(MD). 7451 of 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court S-12. To issue a Writ of Mandamus directing the respondents to pay the petitioner interest at the rate of 18 percentage per annum for the period of delay from the petitioner's date of retirement (31.07.2019) to till date of reimbursement (22.01.2021) of amount paid towards the petitioner's terminal and pension benefits namely EPF Employee's Contribution, Gratuity and Encashment of Earned/Sick Leaves and Commuted Value of Pension, within a time frame as may be fixed by this Hon'ble Court and without affecting his right to claim balance amounts towards those benefits and pass any such other further orders that may deem fit and proper to the circumstances of the case and thus render justice.
