PRAYER: Writ Petition filed under Article 226 of the Constitution of India for issuance of Writ of Certiorarified Mandamus, to call for the records, pertaining to the impugned summon, issued by the second respondent on 29.12.2021 in Na.Ka.No.4575/2021/A1 and quash the same as illegal and consequently to forbear the respondents from disturbing the petitioner's peaceful possession and enjoyment over the property, situated in S.Nos.654/2 and 654/3 to the entire extent of 4 acres (0.81.0 Ares + 0.81.0 Ares respectively), which covered in Patta No.8730, in Jeyamangalam Village, Periyakulam Taluk, Theni District.
