**PRAYER:** Contempt Petition filed under Section 11 of Contempt of Courts Act, 1971, to punish the respondent for the willful and deliberate disobedience to the orders of this Court made in W.P.(MD) No.7300 of 2021, dated 31.03.2021.

**Prayer in WP(MD) . 7300/ 2021 :**

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court S-12. To issue a writ of mandamus directing the respondents to pay interest at the rate of 18 percentage per annum, for the period of delay from the petitioners date of retirement (30.04.2019) to till the date of reimbursement (22.01.2021) of amount paid towards the petitioners terminal and pension benefits namely EPF Employees Contribution, Gratuity, Encashment of Earned/Sick Leaves and Commutated value of Pension, within a time frame as may be fixed by this Honble Court without affecting the petitioners right to claim balance amounts towards those benefits and pass any such other further orders that may deems fit and proper to the facts and the circumstances of the case and thus render justice.
