To issue a Writ of Mandamus to directing the respondent to pay interest at the rate of 18 percentage p.a for the period of delay from 1.5.19 to 24.1.21 in paying the amounts paid towards the terminal benefits of the petitioner namely EPF Employees contribution, Gratuity and Encashment of Earned Leaves within a time frame as may be fixed by this honble court and without affecting his right to claim balance amounts towards those benefits and thus render justice

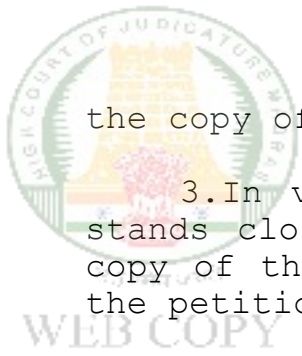
