Prayer in WP(MD). 6649/ 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the respondent to pay interest at the rate of 18 percent per annum for the period of delay from 01.03.18 to 03.11.18 in paying the amounts paid towards the terminal benefits of the petitioner namely EPF Employee's contribution, gratuity and encashment of Earned leaves within a time frame as may be fixed by this Honble court and without affecting his right to claim balance amounts towards those benefits and thus render justice
