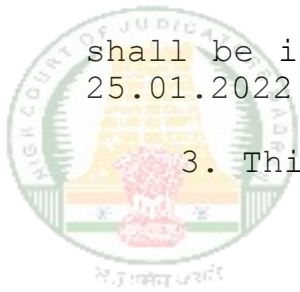
Prayer in CRL OP(MD).No. 20484 of 2021:-
