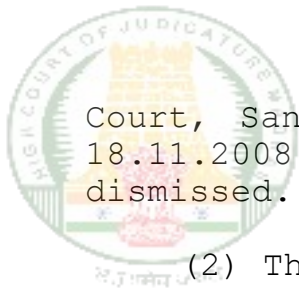
Prayer:-
