(2) That there be no costs in this Second Appeal.

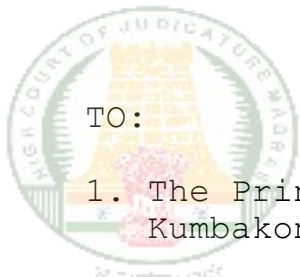
