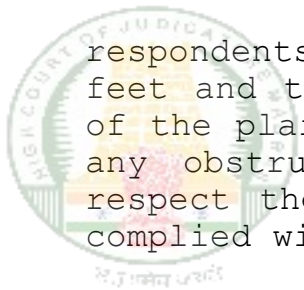
Prayer in SA(MD) . No.324 of 2011:-
