Prayer in CMA(MD). 441/ 2022 :

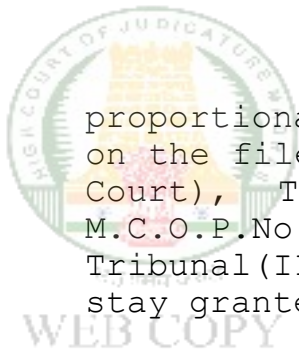
