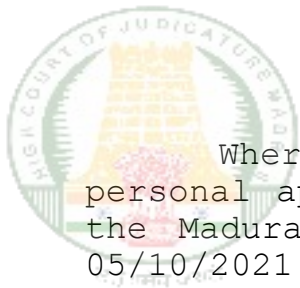
Whereas upon this day the Hon'ble Court while hearing the matter has passed an order as follows:-
