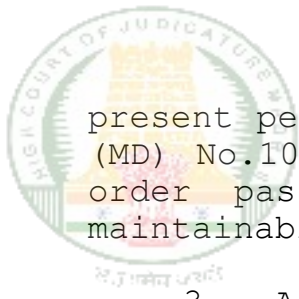
Prayer in CRL OP(MD) . 1071/ 2020 :
