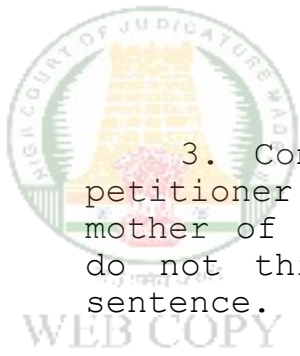
PRAYER IN CRL A(MD) No.10 of 2022:
