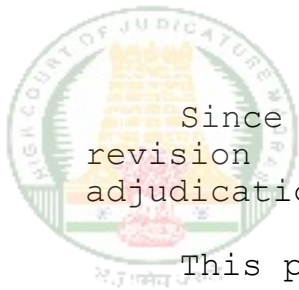
PRAYER IN CRL.MP(MD)No.3343 of 2021:
