Prayer in W.P(MD)No.2848 of 2013: Petition filed under Article 226 of the Constitution of India, seeking for issuance of the Writ of Certiorarified Mandamus' to call for the records of the second respondent in Letter No.25547/FR.Spl.A/2006-18 dated 31.01.2011 and to quash the para 5(i) which declined the approval of cadre post in Coonoor Tea Division and to sanction of the approval of the petitioner's officiation in Cadre Posts for the said period also from 06.08.1980 to 14.12.1982 consequently grant all the service benefits to the petitioner.
