PRAYER : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, direct the respondents to disburse the enhanced compensation under section 28-A of the Land Acquisition Act. As per the proceedings of the first respondent dated 29.5.2009, a sum of Rs. 3,71,320/- together with 15% interest from 31.05.2002 to till the payment is made.

ORDER
