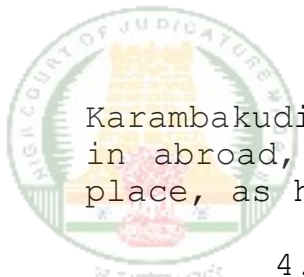

3. The learned Additional Public Prosecutor upon instructions, would submit that the alleged detainee had eloped with one Mohammed, who is a resident of the same area i.e., Kilankadu,

Karambakudi, Pattukkottai Taluk. Though the said Mohammed is living in abroad, the alleged detainee is said to be living in his native place, as his wife.

4. There being no illegal custody or illegal detention involved, this Habeas Corpus Petition is dismissed, reserving the liberty for the petitioner to move the appropriate Court for restitution of conjugal rights, if he is so advised.
