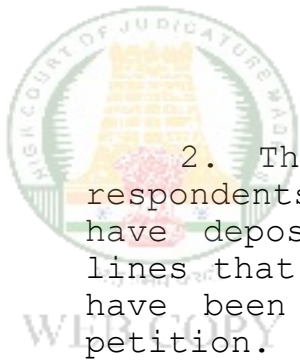
PRAYER : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, calling for the records relating to the proceedings of the first respondent made in Letter No.U.Me.Po/V/Vadakarai/Va.Aa/Ko.DCW/A.No.271/2011, dated 07.09.2011 and the consequential order of the second respondent made in letter No.U.Se.Po/V/Seng/Va.Aa/Ko.Thani/A.No.299/2011, dated 10.10.2011 and quash the same and consequently direct the first respondent to remove the electricity lines passing through the petitioner's property at their cost and pass orders on the same.

ORDER

The present Writ Petition has been filed challenging the order passed by the first respondent herein directing the writ petitioner to deposit a sum of Rs.43,420/- to remove the electricity lines through the petitioner's property.

Hence, nothing survives in the present writ petition.
