2. The learned counsel for the petitioners submitted that the petitioners have been complying with the condition regularly and he prayed for relaxation of the said condition.

3.The learned Government Advocate (Crl. Side) submitted that the first petitioner has not complied the condition regularly and the second petitioner has complied the condition regularly. Investigation is still pending.

4.Taking into consideration of the submissions made by both the counsels an considering the pandemic situation, the condition



imposed by this court in Crl.O.P.(MD)No.20413 of 2021 on 22.12.2021 is modified in respect of second petitioner and the second petitioner shall report before the respondent police once in fifteen days at 10.30 a.m. until further orders and dismissed in respect of the first petitioner.
