PRAYER : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondents 1 to 3 to forbear the 4th respondent or her subordinates from in any way laying a Panchayat road in the land belonging to the petitioner in survey No. 64-2B, 67-1 and 64-3B, Periyasampuram, Vilathikulam Taluk, Tuticorin District, without acquiring the said lands under the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act 2013 by considering the representation preferred by the petitioner on 22/07/2013 within the time that may be stipulated by this Court.
