Prayer : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, to call for the records relating to the seniority list of the year 2011 prepared by respondents 3 to 5 among candidates for promotion to post of Primary School Headmasters in Settubavachathram Union, Thanjavur District and quash the same in so far petitioner is concerned and forbear respondents 3 to 5 from promoting Respondents 6 to 22 to the post of Primary School Headmaster without preparing a proper seniority list and Promotion panel of the year 2012 among candidates to the post of Primary School Headmaster in Sethbava Chathiram Union, Thanjavur District following age wise seniority when date of regularization is the same.

ORDER
